THE BCSME BYLAWS:

2.3 Eligibility for Regular Membership

A Person may be eligible to be accepted as a Regular Member if he or she: (a) is between nineteen (19) and sixty-four (64) years of age; (b) is ordinarily resident in British Columbia and capable, in the exclusive determination of the Board, to fully participate in the Society's activities; and (c) is interested in advancing the purposes and supporting the activities of the Society.

2.4 Eligibility for Senior Membership

A Person may be eligible to be accepted as a Senior Member if he or she: (a) is at least sixty-five (65) years old; and (b) is interested in advancing the purposes and supporting the activities of the Society.

2.6 Eligibility for Junior Membership

A Person may be eligible to be accepted as a Junior Member if he or she: (a) is between fourteen (14) and eighteen (18) years of age; (b) is sponsored by two (2) voting Members in good standing; and (c) is interested in advancing the purposes and supporting the activities of the Society.

2.8 Eligibility for Associate Membership

A Person may be eligible to be accepted as an Associate Member if he or she: (a) is nineteen (19) years of age or older; (b) is ineligible to be accepted as a Regular Member; and (c) is interested in advancing the purposes and supporting the activities of the Society.

NEW MEMBERSHIPS If your membership application is dated after March 1st your dues will be for a period of more than 12 months. The expiry date will be on October 31st in the year following the year in which you apply . See the table below to calculate the dues you must pay when applying for membership.
